NARRATIVE

On Wednesday, January 16, 2019, I was dispatched to speak with Dr. David Sevier, Director of Board of Education Relations and Management. Dr. Sevier stated, School Board Member, Will Pinkston, was being harassed via E-mail by a school board candidate, Thomas "TC" Weber. I looked at the E-mail thread between Mr. Pinkston and Weber. On the E-mail thread at 2314 hours Mr. Pinkston tells Weber not to contact him again or [he] will refer the matter to law enforcement. At 2317 hours Weber responds to Mr. Pinkston. Mr. Pinkston did not respond to Weber and forwarded the E-mails to Dr. David Sevier asking that he refer the matter to school security and metro police. It is my understanding that Mr. Pinkston is not going to file a report with the Metro Police Department at this time, but wanted it document with school security.
